We will wipe down and sanitise shared equipment in the studio after each class. We are limiting the number of students able to participate in one class at a time to 15 participants maximum. There will be allocated spacing on the dance floor for each individual participant in each class. The spacing is for giving participants an appropriate spacing for adhering to social distancing.	WTB, Abbey Sports Centre, and all customers are all responsible for managing the spread of coronavirus. Please use the sanitising hand gel upon entry to the studio, as well as access to a toilet with hand-washing facilities where you can. Customers are advised not to touch their faces as much as possible and refrain from physical contact with another customer who is not from the same household. Abbey Sports Centre has easily identifiable NHS Covid-19 Track and Trace QR codes, to be scanned by everyone if possible. WTB cannot make you scan the codes or have the app for your rights under personal data protections choices. Ensure access is always available to Fire Exits during use of the studio. Recording the attendance of each individual in the class by name, in case of emergency of a fire and a head count is to be completed of each participant in WTBreakers care.	Parents/Carers/Guardians of customers under 18 must be informed at the earliest and safest opportunity by the workshop leader of the situation of fire occurring after safely leading children to the appropriate marked fire assembly points, made responsibly by the site fire wardens of Abbey Sports Centre. Customers over 18 years of age have their own responsibility to self manage after adhering to the safety advice and guidance of the buildings fire safety protocols and also following guidance to the nearest Fire Assembly Point made responsibly by the site fire wardens of Abbey Sports Centre.

Injury from Break dancing tricks, balances, spins, flips, contortions and physical activity when participating in class.	Severe	Likely	Very high	Correct and structured warming up of the neck, wrists, and back with stretches and movements that engage the students effectively. Physical, appropriate, handling to support from falls will be administered with students who need the support for lack of experience and confidence. Helmets are necessary safety gear to learners practice, but experienced practice is advised. Safe physical, appropriate handling of students who are not fully confident in breakdance moves, or who are not well practised, will be helped. Teaching will take place with each student at a safe pace to build to the ability required to complete tricks. Advice will be given up registration of appropriate dance attire.	Students are to maintain attention in class. Teachers are to prevent students from dancing if they miss warm-ups, before attempting the movement. Helmets are to be worn when asked, but beanies are recommended. Parents of students under 18 will complete permission forms on behalf of those participants prior to the class. Customers over 18 will complete permission forms also advising them of the risks. We understand the level of risk with this style of dance, and it is deemed an extreme style of dancing. Please have a thorough understanding of your customer contract.

Participants are also to be aware that they are under instruction and take the instruction from the leader seriously.

Adults in the room are to be class leaders contracted to deliver the class. Classes are hosted in secure facilities, with members only entrances, and security gates, and CCTV. Approaching and making aware to uninvited visitors of their unwelcome presence and direct them away from customers, avoiding possible conflict or endangerment.	It is the responsibility of the studio owner, Abbeys Sports Centre, to ensure there is appropriate customer management, and visitors are regulated. It also their responsibility that the two exits to the studio, the main entrance and fire exit are kept clear and unlocked at all times.
